Enterprise Zone Tax Credits

PEDCO is an approved Enterprise Zone Program. Contributions received are used for the purposes that are directly related to job creation and job preservation. Taxpayers who make monetary or in-kind contributions to the Enterprise Zone Administrator or to an agent designated by the Enterprise Zone Administrator for the purposes of implementing the economic development plan of the Enterprise Zone may claim an income tax credit of 25 percent (25%) of the value of the contribution up to a maximum credit of \$1000,000. To benefit from the deduction for contributions to the program, checks for PEDCO membership dues must be made



payable to the **Pueblo Urban Enterprise Zone**. A notation of "PEDCO Pledge" should be made on the check which should then be delivered to the PEDCO office for processing.

Please Note—Pueblo Urban Enterprise Zone will not accept contribution of less than \$250. In addition, credit cards can not be used for payment of membership dues if taking advantage of Enterprise Zone tax credit.
